Greg said that we have three items on the agenda for approval including (1) the Samueli Academy Board member renewals, (2) the Orangewood Foundation/Samueli Academy Management Services Agreement, (3) the Orangewood Foundation/Samueli Academy Lease Agreement. John Luker presented the 2023-2024 Samueli Academy Budget. John and Anthony Saba addressed questions about the budget.

**EXECUTIVE DIRECTOR** 

Anthony Saba said that the school has just finished 10 years of serving students. The campus looks great. Samueli just held a graduation ceremony for 128 seniors. There is summer school to help students who need to catch up academically, and a FIRE Camp for incoming junior high students. There is an endowment campaign kicking off soon, which will secure long-term funding for certain school programs and positions, such as a school psychologist and alumni program, to exist in perpetuity to ensure continued student success.
